- Boat Training Assess what we need. We have 5 certified water rescue volunteers. We lack rope for water rescue. Purchase price ~ \$5,000 for rope and harnesses. Board recommended a priority list be put together for items needed to buy. Chief report that a boat motor was purchased a few years ago and is still in good shape for use

Levi Robbins reported that they are still having issues getting MS Office working on Dell computer. Dell support is awful
