The Village of Pleasant Hill Board of Public Affairs met in regular session on May 19, 2014. President Stan Fessler called the meeting to order at 7:30 p.m. Roll call: Stan Fessler-present; Kory Krofft-present; and Von Fessler-absent. Others present: Jeff Derksen, Service Superintendent and Karl Marko, Jr., Fiscal Officer.

Citizens Concerns:

Access Engineering Solutions, LLC

Brian May, Access Engineering Solutions, LLC electronically submitted Invoice No. 214819.001-1 in the amount of \$190.00 for professional services on the mitigation of algae at the wastewater treatment plant. Stan moved to authorize payment of Invoice No. 214819.001-1 in the amount of \$190.00. Kory seconded the motion. Roll Call: Stan-yea and Kory-yea. All yeas. Motion carried.

Superintendent's Update:

Village Service Superintendent, Jeff Derksen stated that he received a quote from Ford Hall Company, Inc. in the amount of \$25,208.00 to custom design, manufacture and install a clarifier cleaning system to provide over 50 points of flexibility and adjustment allowing the wier-Wolf system to remove algae and debris from the clarifiers. In addition, Jeff provided a letter from Brian May, Access Engineering Solutions, LLC recommending that we accept the quote from Ford Hall. After some discussion on this approach to mitigate the algae problem and the amount of the quote, Kory moved to accept the bid from Ford Hall Company to install brushes on the clarifiers. Stan seconded the motion. Roll Call: Stan-yea and Kory-yea. All yeas. Motion carried. Jeff said that he would get in touch with Ford Hall and tell them to proceed with the project.

Mr. Derksen then reported that he has finished the 2013 Water Consumer Confidence Report. The Board then discussed the possibility of posting the report on our website and running an ad in the Stillwater Advertiser telling residents of the Village that they can read the report on the Village Website. Also, if someone does not have access to a computer, they can call the Village office and request a hard copy of the report. It was decided that this would be the most efficient way of distributing the report to residents of the Village.
