The Village of Pleasant Hill Board of Public Affairs met in regular session on July 20, 2020. Superintendent's Update:

Jeff reported that the Speed Sensor on the Generator at the Waste Water Treatment Plant went bad and that Cummins-Bridgeway submitted approximate estimate of \$2,000 to repair the Generator. The Board gave Jeff permission to get the Generator repaired.

Further, Moody's had completed the rehabilitation of Well No. 5 and when they fired up the pump, it was not pumping at the desired pressure. Therefore, they took the pump back to the shop to analyze why the pump was not working as required. As soon as they bring the pump back, Well No. 5 will go on line.

Village Office Update:

Mr. Marko reported that Council adopted the 2021 Budget. However, he reminded the Board that the Council will not adopt the 2021 Annual Appropriations until January 2021 and the Board has time to adjust the 2021 budget for the funds that the Board manages.

Fiscal Officer Marko analyzed the billing cycle that ended June 26 to determine the difference between what was pumped and what was billed to our residences. For this billing cycle, we pumped 5,331,002 gallons and billed 4,531,000 gallons. This is a difference of 800,002 gallons for the billing cycle or 13,114.79 gallons per day. However, Karl reminded the Board that Village employees flushed all fire hydrants and water mains during this period.
