After considerable discussion, the Board decided to delay any decision on the increase of the Sewer Capital Improvement Fee until Unless the Village has another twenty homes built inside 2018. corporation limits, an increase in the fee must be made to meet future debt obligations. The maximum fee increase that will be needed to meet the current debt payments should be no more than \$1.00 per month.
