

VILLAGE OF PLEASANT HILL, OHIO

ORDINANCE 1003

**AN ORDINANCE AMENDING SECTIONS 150.012, 150.041,
150.046, AND 150.159 OF THE PLEASANT HILL ZONING CODE**

WHEREAS, the current code sections 150.012, 150.041, 150.046, and 150.159 are not consistent with current practices and;

WHEREAS, the Village of Pleasant Hill desires to have its code in conformity with current practices;

BE IT ORDAINED, by the Council of the Village of Pleasant Hill, Miami County, Ohio, three fourths of the members elected or appointed approve that:

SECTION ONE: Section 150.012 of the Pleasant Hill Zoning Code is hereby amended to read as follows:

150.012 ACCESSORY USE

- (A) Private garages for storage of vehicles of residents and employees.
- (B) Home occupations.
- (C) Pools. Swimming pools for use by residents and guests only, provided such pools are set back 15 feet from all lot lines and enclosed with a fence 5 feet high.
- ~~(D) Sleeping rooms. The renting or leasing of rooms by a resident family, provided the number of roomers does not exceed two in any dwelling unit.~~
- ~~(E) (D) Signs permitted as accessory uses. See 150.156.~~

SECTION TWO: Section 150.041 of the Pleasant Hill Zoning Code is hereby amended to read as follows:

150.041 PERMITTED PRINCIPAL USES

- (A) Two-family dwellings.
- (B) Apartment houses and apartment hotels.
- (C) Multiple dwellings.
- ~~(D) Boarding houses:~~
- ~~(E) (D) Churches an similar places of worship.~~
- ~~(F) (E) Parish houses and convents in conjunction with churches~~

- _____ or schools.
- _____ ~~(G)~~ (F) Public community center buildings, parks, playgrounds, and
golf courses.
- _____ ~~(H)~~ (G) Public and parochial schools.
- _____ ~~(I)~~ (H) Public libraries.
- _____ ~~(J)~~ (I) Row houses.
- _____ ~~(K)~~ (J) Town houses.
- _____ ~~(L)~~ (K) Mortuaries or funeral homes.
- _____ ~~(M)~~ (L) Condominiums.

SECTION THREE: Section 150.046 of the Pleasant Hill Zoning Code is hereby amended to read as follows:

150.046 ACCESSORY PARKING

- _____ (A) There shall be provided two parking spaces per dwelling unit.
- _____ ~~(B)~~ There shall be provided one parking space for each two
roomers.
- _____ ~~(C)~~ (B) For parking space required for other than residential uses,
see 150.153.

SECTION FOUR: Section 150.159 of the Pleasant Hill Zoning Code is hereby amended to read as follows:

150.159 MODULAR HOMES

NO Modular Homes ~~approved by the "Ohio Basic Code",~~
SHALL BE approved for building by this code.

SECTION FIVE: That all ordinances or resolutions in conflict with this Ordinance are hereby amended to be consistent with this Ordinance.




