

**VILLAGE OF PLEASANT HILL, OHIO**

**ORDINANCE NO. 1123**

**AN ORDINANCE APPROVING AN INCREASE IN THE MONTHLY RATE FOR CURBSIDE SOLID WASTE AND RECYCLING COLLECTION FOR THE RESIDENTS OF THE VILLAGE OF PLEASANT HILL, RESCINDING SECTION 11 OF ORDINANCE NO. 1113**

**WHEREAS**, the Village's monthly cost (amount paid to Rumpke of Ohio, Inc.) per unit for solid waste and curbside recycling collection for the next five (5) years, March 2021 through December 2025, will be as following:

2021 - \$20.75 per month

2022 - \$21.17 per month

2023 - \$21.81 per month

2024 - \$22.46 per month

2025 - \$23.14 per month

**WHEREAS**, the latest agreement with Rumpke of Ohio, Inc. calls for replacing the recycle bins (18-gallons) with recycle carts (65-gallons) and,

**WHEREAS**, Council desires to keep the cost to our residents as low as possible, recycling collections will be every other week.

**WHEREAS**, it is determined that this will be in the best interest and for the Health, Safety, Welfare and General well-being of the residents served by the Village of Pleasant Hill, Miami County, Ohio.

**BE IT ORDAINED**, BY THE COUNCIL OF THE VILLAGE OF PLEASANT HILL, MIAMI COUNTY, OHIO, A MAJORITY OF ITS MEMBERS ELECTED OR APPOINTED THEREFORE CONCURRING AS FOLLOWS:

**SECTION ONE:** That the Council of the Village of Pleasant Hill has decided to increase the monthly rate including administrative costs incrementally over the next five (5) years to cover the costs listed above. For 2021, the rate, for the weekly solid waste and every other week curbside recycling collection service, will increase to \$21.00 per month (bimonthly bill of \$42.00). For 2022, the monthly rate will increase to \$21.50 or \$43.00 for the bimonthly bill. For 2023, the monthly rate will increase to \$22.00 or \$44.00 for the bimonthly bill. For 2024, the monthly rate will increase to \$22.50 or \$45.00 for the bimonthly bill. For 2025, the monthly rate will increase to \$23.50 or \$47.00 for the bimonthly bill.


**SECTION TWO:** The rate increase will be effective as of the billing period beginning March 1, 2021. All subsequent increases listed in Section Two will be effective as of January 1 of each subsequent year.


**SECTION THREE:** That the charges established for solid waste and curbside recycling collections shall be billed to the residence owner or other person designated by the owner and shall be payable bi-monthly, by the due date specified on the statement. There shall be a penalty of twenty percent (20%) of the bi-monthly charge for refuse, if any amount thereof is not paid by the indicated due date. This penalty is in addition to any other applicable rights the Village may assert in collection amounts owed for the refuse service, including, but not limited to the assessment of liens on the property owner.
